Fees

Fees are payable for the use of the Airport facilities. Charges are set by Diamantina Shire Council as per their Schedule of Fees and Charges. Passenger fees applicable to the flights to be collected by the operator and paid daily to the Airport Operator. A wristband will be issued. The fees being \$20 per passenger. Different coloured wristbands will be issued for each day. For the above purposes the "Airport Operator" is Diamantina Shire Council.

Access and Parking

Allocation of parking area for operations will be notified by Airport Manager. Access to the airport will be available through the access gate near the Hotel. Each Pilot acknowledges the condition of the airport and undertakes to conduct all taxying and flights to minimise nuisance to other users etc. Charter passengers are to be accompanied by the Pilot while within the secure airport area. Where practicable aircraft are to be manually manouvered into final position to avoid dust and stone hazard. Where parking clearance lines are marked on the tarmac, the aircraft should be parked completely behind the parking clearance limits. Parked aircraft are to be suitably secured and parking brakes applied due to taxying aircraft including rotary wing aircraft.

SEZ and NOTAM
